## 10:00 a.m.-12:00 p.m. via Zoom

- a. IIC responded quickly and shared stretch goals that will align with the set standards
- b. 102% of 5-year average was their recommendation
  - i. They will recalculate numbers every year to get a 5-year average
- c. Was approved by Faculty Senate
- d. PAC doesn't meet until April 13, after the report is due, but will try and push for an emergency vote meeting
- e. IIC will revisit the entire process after the annual report
- 2. Naming conventions and file storage
  - a. All documents must be accessible to the public
  - b. It's best to standardize a naming process
  - c. Librarians suggested something like "IIB\_2\_5\_FileName"
  - d. Danielle suggested something like the midterm report "6.A.3.1 File Name"
  - e. This is something that can be discussed with partners during breakout sessions
  - f. Everyone decided to re-visit this later

#### **New Business**

- 1. Coordination with Cypress and NOCCCD
  - a. The committee will coordinate with Jill Bauer, who is the faculty co-chair at Cypress, as needed
  - b. They must reach out to District if a piece of evidence is needed—José Ramón will make the initial contact
- 2. Standards report/updates (information with possible action)
  - a. Standard I
    - i. They had their first group meeting
    - ii. They are getting to know the standard
    - iii. Working on an evidence matrix
    - iv. Looking for more classified representatives to join their workgroup
  - b. Standard IIA
    - i. They are also getting to know their standards
    - ii. They are focusing on the verbs to see what each standard is saying
    - iii. They are hoping for counselors and classified staff to join their team
  - c. Standard IIB and IIC
    - i. Service Area Outcomes
    - ii. The groups are meeting separately for now, but will meet together soon
    - iii. They are looking into how to collect data and evidence and how it can be measured
    - iv. Josh will meet with deans and managers to review templates
    - v. They will follow up on the data Dashboard process
    - vi. Their priority right now is to continue the process with non-instructional programs to come up with or work on outcomes
