Annual SLOAC Summary Report for year 2021-2022 (Presented by George Bonnand)

Summary Report (as of 4-9-22) (Note: Student Learning Outcomes | Fullerton College (fullcoll.edu))

The following is a summary of the items that the SLOAC committee has done over the past 2021-22 academic year.

- SLOAC members meet regularly during the academic year to address CSLOs and PSLOs issues as well as Elumen issues that faculty have. There are twelve members plus one student representative on the SLOAC.
- Review and updating of Course Student Learning Outcomes (CSLOs) each semester is an ongoing manual process performed by all members of the committee. At this time all courses have CSLOs attached to them however there are 197 CSLOs of 3597 CSLOs that do not have an assessment associated with them. See Figure 1.
- Per the guidance of and request of the Guided Pathways Group IV, Program Student Learning Outcomes
 (PSLOs) are being reviewed and revised by department personnel using a rubric. Once the PSLOs are revised by
 the departments they are reviewed/approved by the assigned SLOAC sub-committee. Once approved they are
 submitted to the Curriculum Committee for review and implementation into CNET prior to being input into the
 Elumen system.
- Review and updating of mapping of CSLOs to Program Student Learning Outcomes (PSLOs) is now possible if
 they are present in the Elumen system. Review and updating of mapping of CSLOs to PSLOs and then PSLOs to
 ISLOs is an ongoing manual process performed by all members of the committee. Since CSLOs are no longer
 mapped directly to the ISLOs not all CSLOs are currently mapped to the new PSLOs or ISLOs in Elumen. There
 are 769 CSLOs of 3597 that are unmapped to either PSLOs and/or ISLOs. See Figure 1.
- Alignment of SLO Cycle and PRC cycle is now complete. This was done to facilitate the Program Review and the SLO review process.
- Commencement of ACCJC Accreditation information/data research has begun (as of 4-9-22) with several committees and workgroups which some SLOAC members are part of. As course data is needed from Elumen, reports will be provided as best as possible by the SLOAC chairperson or designee.
