Action Items:

As per our meeting, there is a lot to digest and there are a number of action items that will need to happen jointly by several committees for the implementation of revised PSLOs. We have at least one action item (which may be comprised of several items). The following is the action item for our committee for next time we meet as I see it:

- Develop a plan/process (ideas and thoughts on paper if possible) for how PSLOs should be submitted to our committee for review and approval. Please try to have something prior to our next meeting on 5-7-21. The plan/process could include the following:
  - Template for PSLOs submission (format, worksheet, examples, submit through a website?, etc.)
  - Method of evaluation of PSLOs (use developed rubrics by Workgroup #4? review of CSLOs> PSLOs>ISLOs chart to make sure they make sense and are written correctly? are they linked? etc.)
  - Method of approval (vote by committee or other? record in meeting minutes? paperwork documentation? etc.)
  - Once approved-submission to curriculum committee via CNET as a minor revision for implementation will need to happen. (This CNET process is well defined and can be done by faculty members or a member of the committee. Do we submit it for the departments? or do they submit it on their own through the CNET process? how do we insure it does not get stuck in the process or our process is circumvented? or other?)
  - Process flow chart of how PSLOs should flow through our committee. (timelines?, steps?, actions?, etc.)
  - There might be more things to consider here but the listing above should get us started.
- Change mapping process in Elumen so that we can map CSLOs to PSLOs and PSLOs to ISLOs. This can be done fairly quickly by me.
