III. APPROVAL OF THE MINUTES OF THE PREVIOUS MEETING

IV. PUBLIC COMMENTS

Josh Ashenmiller shared his concern regarding a possible "summer surprise" regarding dual enrollment. Full-time faculty in the Social Sciences Division have expressed their views regarding courses that are and are not appropriate to be taught at the high schools. And he is concerned that despite that, courses could be offered to adjunct faculty to teach anyway.

Tim Ream informed senators of the new program "Author Talks" being offered by faculty in the library. This program brings in a variety of bestselling authors and thought leaders to discuss their books in a moderated, live stream fashion.

Elsa Perez shared the following statement:

I wanted to express how thankful I am to have the opportunity to serve as a Faculty Senate Senator. It was a pleasure serving for the Counseling and Student Development Division. As a woman of color, I appreciated the meaningful discussions and different perspectives. As I reflect on my two years as a senator, I learned that disagreements will happen, but it is important to have communication, respect and remind ourselves what our role is as senators. More importantly, how our decisions will impact our students. I feel that more than ever, we need to collaborate more effectively and focus on the needs of our students. I want to thank our executive team for their support and for their leadership. I acknowledge the work that is being done now to improve our efforts when it comes to the 10+1. One example of that is updating our bylaws and soon the constitution. I also want to mention that our collaboration does not

only mean within faculty. Our collaboration extends with staff, students, and administration. Thank you for your time.

On behalf of the Ethnic Studies Department, Rosie Kar thanked everyone for their support for the Ethnic Studies 50th Anniversary. She asked for continued support for the Ethnic Studies Endowed Scholarships in honor of Adela Lopez, Gerald Padilla and Ernest Bridges. She also thanked Dr. Olivo and Chancellor Breland for their support in sending a team to the Asian Pacific American in Higher Education (APAHE) Conference.

Jessica Langlois shared that the latest edition of Inside Fullerton is now available. And, on behalf of faculty in the Photography Department, expressed concerns that the new lab parity has on adjunct faculty in their department. Adjunct faculty are capped at 6 units and now with parity two classes with lab components equals 8 units. This mean that adjunct faculty in their department can no longer teach two classes.

Items of note from the PBSC Meetings 5/17/23

- PBSC received a presentation of a proposal to use ER 2.0 funds to help create a STEM Center from Bridget Salzameda, Dean of Natural Sciences and Professors Jake Shapiro, Americo Fraboni, Seung Ji, and Spiros Dimitrados.
- PBSC discussed the process and timing of applications for year two ER 2.0 funds and voted to solicit those at the beginning of the fall semester, 2023.
- PBSC took a first look at Program Review Resource Requests from the Program Review and Planning Committee (PRPC) and approved by Faculty Senate.
- Co-Chair Berumen shared some challenges of the current program review process for approving funding requests and of the PBSC process for acting on the PRPC recommendations and asked reps to think about how we could improve our processes moving forward.

Items of Note from President's Advisory Council (PAC) Meeting 5/10/23

- Dr. Olivo provided PAC with an update on the plan for taking the FC mission statement back to the BOT in the fall with an explanation of why we are so invested in the language we developed through our campus participatory governance process.
- PAC approved the creation of the new Strategic Enrollment and Retention Committee (previously approved by Faculty Senate).
- PAC approved applications for grants:
 - ANAPISI program: APIDA Amplified (see attached AANAPISI Grant APIDA Amplified)
 - 2. Title 5—Developing Hispanic Serving Institutions Program, Dual Enrollment (see attached Concept Paper Title V 2023)
 - 3. NSF Network of Equitable Science Training (NEST), STEM Center and Coordinator
 - 4. California Community Colleges Chancellor's Office Community Colleges Pathway to Law School Initiative (Cal LAW), for Cal LAW Program Expansion, through Dual Enrollment (see attached Concept Paper Cal LAW 2023)
- PAC discussed the challenges of not having the opportunity to review grant proposals until the day of our last PAC meeting of the semester, as well as concerns about sustainability post-grant funding and the grant process, especially when positions are included.

Items of Note from the District Council on Budget and Finance (CBF) 5/8/23

 Cypress College President Dr. Joanna Schilling presented on the proposed Follett Access textbook program pilot.

- CBF approved the use of \$5 million dollars from the district's remaining COVID monies to subsidize textbook costs for students in 2023-2024, if the proposed Follett Access Program pilot is approved by the Faculty/Academic Senates. In response to a question from faculty reps, Vice Chancellor Williams indicated it could be possible to use this money to assist students with the cost of course materials in a different way.
- CBF approved Foundation Funding of \$900K, \$450K for FC and \$450K for Cypress, for a three-year period to support operations while the Foundations raise more ongoing sustainable funding.
