1. Reinstitute campus wide health promotion programs such as smoke out, pet therapy etc. That improve student health. *We have filled the health education coordinator position and she has been busy implementing campus wide programming- including Mellow into Midterms, World AIDs day, Weekly RAD care meetings, Red Cross Blood Drive, Rest and Relaxation for finals week. Participation in multiple campus events providing health education.*
2. Decrease student illness (I.e. flu/COVID) by providing access to vaccines. This will improve attendance and retention. On campus vaccine clinics will remove barriers to vaccine access. *Changes in public health policy has limited our ability to have COVID vaccines on campus but we had a wildly successful flu vaccine clinic in Fall 2023 and vaccination 100 students and staff!*
3. Improve student experience by involving students & community in Student Health Advisory Board with a focus on social determinants of health and the impact of climate change on health. *We are working on planning and recruitment for Spring 2024 semester.*
4. Improve healthcare delivery to student population by understanding trends in college health care and utilizing evidence-based medicine. *We are in the planning stages of implementing the ACHA/NACHA survey for Spring 2024.*
5. Increase the number of students served each semester by utilizing campus specific survey data to tailor health education programs and health services clinical offerings. *In process of researching options.*
