Summary of Activities:

The Campus Collaborations Team (CCT) met twice in the fall, and three times in the spring term. The committee discussed the following topics:

1. Support for Associated Student (AS) Members:

In a continuation of their discussion from spring 2023, CCT invited new AS Faculty Advisor Ron Farol to discuss ways that committees could better recruit and support AS representatives. Ron shared an open invitation for all chairs to attend AS meetings to report on committee work and recruit students. The chairs were all once again reminded to carve out time to meet with their AS reps before/after meetings to help onboard them to the process.

2. Committees Website

CCT co-chair Daniel Berumen, Program Review and Planning co-chair Bridget Kominek, and Campus Communications worked together to help update the committees.fullcoll.edu website so that all committees were represented on the site. This meant sunsetting standalone committee sites for Program Review and Student Equity, and collecting agendas, minutes/notes, and membership from every committee on campus. The initial work was completed in December 2023, and updates will be ongoing.

3. Integrated Planning Workgroup Proposal

The Integrated Planning Workgroup proposal was a collaborative effort between members of the Institutional Integrity Committee, Accreditation Steering Committee, Planning and Budget Steering Committee, and Program Review and Planning Committee. The CCT was used as a space to share out progress on this project throughout the year.

4. Accreditation

The CCT was also used as a space to share progress on accreditation work, including sharing out information about the additional evidence required, the forum with the visiting team, and the work over the summer to address our "Core Inquiry".

Work Moving Forward

The 2023-2024 academic year was the first full year of the CCT and the group is still identifying how best to leverage the opportunities the committee provides. For example, CCT members discussed the need for standardization on committee chair paperwork and reporting. The group made strides in making sure everyone was keeping and publishing notes, agendas, and yearend reviews, but every group is still completing these differently and there is no process to evaluate whether committees have been meeting their goals and functions. In fact, at the last meeting of the year (May 7, 2024) co-chair of the Guided Pathways Steering Committee Matt Taylor shared the need to make sure the CCT is identifying plans to implement the work it discusses and follow-up on their progress. For 2024-2025, CCT could set an example for other committees on evaluation and accountability of committee work.
