I. CALL TO ORDER

The meeting was called to order at 3:02P by Bridget Kominek.

II. APPROVAL OF THE AGENDA

IV. PUBLIC COMMENTS

Eli Costello shared that the Access-Ability Club has been reinstated. Forty students have already signed up, and the club needs a faculty advisor.

Deniz Fierro shared information about the 29th Annual Adopt-an-Angel holiday event and shared that EOPS is currently accepting applications for spring 2026.

Cecilia Arriaza reminded senators of the 1-Dec deadline for UC and CSU applications for students transferring fall 2026. The Transfer Center will be open Saturday, 22-Nov to provide application assistance. She also reminded senators that the deadline for students to apply for the Jack Kent Cooke Foundation scholarship is 7-Jan.

Paulette Chaffey shared information about a Drive-thru Thanksgiving Food Drive on 22-Nov at Fullerton Free Church. She reported that she attended the Performing Arts Center Groundbreaking and thanked those who participated.

Mike Mangan reminded senators of the Study Abroad Fundraiser taking place after the Senate meeting today.

Laura Anaya Jurado invited senators to attend "A Conversation with Javier Zamora" on 21-Nov. She also informed senators that KinderCaminata will take place 24-Apr.

Jodi Balma – Political Science Department Coordinator & Honors Program Coordinator I'm very opposed to the creation of an INDS Workgroup.

The Shared Governance model of 10+1 includes Curriculum as a committee of faculty with divisional representation. This seems like an egregious attack on that shared governance and disregards the hard work the members of the Curriculum committee have engaged week after week with granular knowledge of these issues.

Anyone who has attended one of their meetings or created curriculum has seen the immense workload they process every week. Each of our division representatives has a voice and have been debating this issue for years on this committee.

If there are questions about the INDS degrees, the Senate should ask the Curriculum Committee to answer their questions, not bypass them with a new workgroup.

Martha Smith – Philosophy & Religious Studies Department Coordinator

I appreciate the renewed interest in understanding the role of INDS-AA degrees. I am against the formation of a workgroup at this time, as it appears that the questions of the working group can be addressed by the Curriculum Committee itself. The Curriculum Committee has the institutional experience and specialized knowledge to answer the questions posed by the proposed group; the proposed work falls under the established purview of the committee; and the committee is also a space where this work can be done transparently with equal divisional representation from the elected members of the committee. Thank you.

Karin Pavelek – Child Development & Educational Studies Department Coordinator

Our CDES department appreciates the Senate's initiative in forming a workgroup to oversee INDS AA degrees; however, this responsibility rightly belongs to our Curriculum Committee, which includes faculty with divisional representation. Establishing a separate workgroup risks undermining shared governance and could lead to biased decision-making. Questions or concerns regarding these degrees should be addressed by the Curriculum Committee, whose members are experts in curriculum and degree oversight. INDS degrees should not be treated as a separate entity but managed consistently with all other degrees and certificates under the committee's purview. Creating an additional workgroup introduces unnecessary duplication and potential bias, whereas the Curriculum Committee ensures decisions are made collaboratively and equitably within the framework of shared governance.

Kristen Shedd – History Department

I would like to express my opposition to the creation of an INDS workgroup. The time, effort, and expertise of the Curriculum Committee, and especially its standing in the shared governance process, should be respected. The Curriculum Committee, like any of our other committees, is part of an agreed upon and thoughtful process of governance. While not all decisions from senate faculty committees are popular, they are transparent and follow the structure of shared governance with divisional representation.

Kelly Nelson-Wright – Sociology Department Coordinator & Social Science Division Curriculum Committee Representative

Forming a separate Senate curriculum work group would be an inefficient and inappropriate duplication of the Curriculum Committee's authority and expertise, undermining the established shared governance process. The Curriculum Committee, with its extensive training and experience in curricular analysis, including specific concerns about faculty input on INDS degrees at Fullerton College, is the designated body for such work. Establishing a new group would bypass the committee's divisional representation and specialized knowledge, and

its recommendations should be respected to uphold the integrity of the shared governance system.

The Academic Senate for California Community Colleges recognizes the Curriculum Committee as the primary mechanism for exercising faculty primacy in curriculum development, evaluation, and renewal. This faculty primacy is legally confirmed by the state legislature and the Board of Governors. The Curriculum Committee is the official vehicle for developing curriculum recommendations, which are then presented to the governing board, as outlined in Title 5.

I strongly urge the rejection of a new curriculum work group. I encourage all Senate members to support the shared governance process by respecting the authority and recommendations of established Senate Committees, particularly the Curriculum Committee.

Ruben Lopez – Geography Department Coordinator

Curriculum must be overseen by faculty with discipline expertise rather than by academic counselors. Faculty experts have a depth of knowledge in their specific disciplines and can ensure that students are engaging with core theories, methodologies, and standards of those fields. Unlike traditional single-discipline majors with a clear curriculum, interdisciplinary programs require faculty to help students connect diverse ideas, maintain methodological standards, and prepare for unique career paths; therefore, it is imperative that academic faculty have oversight to guide students through the complexities of integrating different fields and ensuring the program has academic rigor. The INDS degrees, in their current form, are not interdisciplinary but multidisciplinary. There is a difference. Interdisciplinary study involves collaboration and integration to analyze, synthesize, and harmonize different disciplines into a cohesive whole. Scholarly work maintains shared goals and a coordinated approach. There is intention in every aspect of program development. Multidisciplinary study involves multiple disciplines working on a problem, but from their own separate viewpoints without coordination or intention. No true interdisciplinary degree would list 90+ possible courses. Discipline faculty understand the difference.

Undermining the shared governance process by creating an IDES-AA workgroup sets a dangerous precedent whereby the legitimate outcome of a vote, perhaps undesirable to some, is questioned and negated simply because they did not agree with the result. How very Trumpian.

Finally, it needs to be said that the Faculty Senate and the Senate Exec are close to advocating for a "separate but equal" policy in degrees. The current iterations of the INDS degrees are not as rigorous as discipline degrees. Institutional racism takes many forms. One of the most subtle yet nefarious is racial bias in setting lower expectations for minority students. What we are saying as an institution is that we do not believe certain students, athletes, first generation, non-traditional, and others can achieve more rigorous discipline degrees. Lower standards create a convenience for the institution at the expense of students' future potential in a competitive world. We are perpetuating inequity with these INDS degrees; not increasing access. The Faculty Senate should be discussing how to better support all students in achieving standards set by disciplines rather than selling these "work around" degrees to our most vulnerable.

Francis Mummery – Economics Department Coordinator

The formation of committees like the Curriculum Committee allows for the specialization and division of labor whereby greater efficiency and better outcomes can be

achieved. The proposal of Senate Exec to form an INDS AA-degree work group upends the process that is in place. Moreover, it is disrespectful to the members of the Committee that have spent an immense amount of time and work over the course of years. If the efforts of such committees is to be ignored or discarded by actions of Senate Exec, then it calls into question why we would even have any committees at all.

I am strongly opposed to the formation of the proposed sub-group. It is a bad idea to disregard the work of those that have taken the time to thoroughly study an issue. Moreover, it sets a bad precedent indicating that established processes can be capriciously ignored.

Gary Graves shared that he is the faculty representative on the District Technology Committee. They are discussing a district AI policy. They are also discussing retiree emails. He shared information about an event on 1-Dec where faculty can learn how to build their own AI Chatbot. Entrepreneurship Week will be the week of 9-Mar and more information will be forthcoming.

Elizabeth Flores shared that the Students of Distinction event will take place 1-May. Faculty are needed to serve on the selection committees, and changes will be implemented based on feedback they received last year.

Lorena Marquez shared that Major Discovery Day will take place on 10-Mar and invited faculty to participate.

- Guardado will be participating in that as our college's professional learning coordinator, and she will share feedback developed by our Professional Learning Committee. When the workgroup has a draft that it is ready to present to DCC, I will share that with Senate so that you can guide myself and Brandon Floerke when we vote on the revised AP at a future DCC meeting.
- The district finance office and the Council on Budget and Facilities (CBF), a subcommittee of DCC, is continuing to work on revising the district's Resource Allocation Model (RAM). The first proposal will be voted on at DCC on 11/24, which is why I asked to have it added to today's agenda. The other three items will continue to be discussed at CBF and will be refined and voted on at a future DCC meeting. Please continue to share these with your constituents so faculty are well-informed and you have a good sense of your constituents' perspectives when they come back as voting items.
- Brandon and I attended the Institutional Effectiveness Coordinating Council
 (IECC) meeting on 11/17. This subcommittee of DCC is looking closely at data
 from the district climate survey that we completed in Spring 2025. We
 brainstormed how to make forward progress to improve two key areas where
 we saw lower employee satisfaction: communication from leadership regarding
 decision-making and participation in decision-making. I expect that at an early
 Spring 2026 Senate meeting I will be soliciting input from Senators with ideas for
 how to improve these two areas. This group is also making plans for reporting on
 our current district strategic plan and the upcoming plan; I represent our faculty
 on the District Design Committee.

In General:

In November, the curriculum committee discussed the following items:

- Ensuring that a course approved for the local Associate GE pattern is placed in the catalog and the guide sheet, even if the course is rejected by Cal-GETC for the same area. This is not a policy change; it is enforcement of existing policy.
- Recommending lower-division GE requirements for the baccalaureate degree.
 Our recommendation will be discussed today, at Senate.

- DCCC's concerns about class size inconsistencies among the two community colleges, as well as a general lack of adherence to the Class Size Planning and Resource Document.
- The possibility of a workgroup regarding the INDS degree
- Both the curriculum committee and DCCC are addressing ways of approaching the numerous Title 5 changes requiring revisions to our course outlines.
- Coursedog timeline for 2026.

Curriculum Development Reminders:

We're now processing and approving curriculum for Fall 2027. We strongly recommend that faculty prelaunch Fall 2027 courses now if they require approval from UC transfer and Cal-GETC.

Cal-GETC timeline:

Courses that were Board-approved and accepted for UC TCA (UC transfer) will be sent to Cal-GETC in November 2025. In May 2026 or June 2026, Cal-GETC will inform the articulation officer which courses are approved or disapproved.

Common Course Numbering (CCN) Update:

Phase 2B CCN templates have been published. 2B, along with Phase 3, will have an effective date of Fall 2027.

As I mentioned at the last Senate meeting, the state chancellor's office will allow us to update ADTs for CCN Phases 2 and 3 without submitting them to the state, if the CCN update is the only revision. Like we did in May of 2025, we'll sign a form to be sent to the chancellor's office.
